3 Key Elements of an Introduction:

*Note: this is not a suggestion for structure.



- What are the aims of this research?
- What is the context (social, political, economic or theoretical) of the topic?
- What are the key terms to be defined?



- Why is this area of research significant?
- In which ways, does it fill a gap in the current research?
- Why is it important to your practice?



- How will this topic be covered?
- Which key practitioners or theories are used?
- Which main aspects will be discussed?
- Have you limited your focus to a particular aspect? Why?
- What might you seek to argue overall?

- This report aims to ...
- According to ... (year, p.), X can be defined as " ..."
- X is a major area of interest within ... as ...
- There is an ongoing debate surrounding ...
- My interest in this area developed while I was ...
- · One key theory utilised is ...
- The research centres around examples from ... as ...
- The main areas to be addressed in this report are a), b) and c) ...
- Chapter ... discusses ...

3 Key Elements in Conclusions:

*Note: this is not a suggestion for structure.



- What did the assignment aim to cover?
- What were the key findings?
- Were there any unanswered questions?

So What?

- So what is your overall stance to the title or question set?
- So what can be learnt from this?



- What further research or actions could be carried out next?
- How could this research influence your future practice?

Phrases for Conclusions:

- This essay discussed ...
- The research showed that ...
- The most significant finding to emerge was that ...
- A question for future research is ...



Checklist for Conclusions (adapted from Godwin, 2014, p. 59)

Does your conclusion	Tick
Briefly restate your original aims or questions?	
Provide a summary of the main findings?	
Answer the question or title?	
Avoid any new information (unless it is connected to the future)?
